A Deal with the Lot Promotion Terms and Conditions

Background to Promotion

- 1. Mirvac WA Pty Ltd (**Mirvac** or the **Promoter**) recently introduced the A Deal with the Lot Promotion (**Promotion**).
- 2. The Promotion will run for a limited time. The Promotion commences at 10.00 am (WST) on 17 August 2019 and ends at 5.00 pm (WST) on 31 October 2019 (**Promotion Period**).
- Under the Promotion, subject to these terms and conditions, an Eligible Buyer will be entitled to obtain up to \$25,000 rebate on the Purchase Price (inclusive of GST) of an Eligible Lot, at Settlement and to Eligible Buyers who purchase a lot at One71 Baldivis (Eligible Property) during the Promotion Period.
- 4. Mirvac make no representation or guarantee that the purchaser will receive a builder incentive from a participating builder and may be subject to terms and condition of the participating builder.
- 5. The following terms and conditions apply to the Promotion. By participating in the Promotion, Eligible Buyers agree to be bound by these terms and conditions.

Promotion Terms and Conditions

The Eligible Buyer will only be entitled to take part in the Promotion if the following terms and conditions are satisfied:

- 6. The Promotion is for buyers who:
 - a. are natural persons over the age of 18 years and are not a company, registered builder, superannuation funds or persons acting as agent on behalf of other persons;
 - b. have not been referred to Mirvac or One71 Baldivis by a referring channel agent;
 - c. are not an employee, agent, consultant or related entity of Mirvac;
 - d. enter into an unconditional contract of sale with Mirvac for the purchase of an Eligible Property (**Contract**) during the Promotion Period;
 - e. pay the full deposit required under the Contract on or before the date required by the Contract;
 - f. comply with the terms of the Contract and are not otherwise in default under the Contract; and
 - g. settle the acquisition of the Eligible Property on the due date for settlement required under the Contract,

(Eligible Buyer).



- Subject to complying with the terms and conditions of this Promotion and the provisions set out in special condition 1 of the Contract, Mirvac will offer the Eligible Buyer a rebate to the value of up to \$25,000 on selected homesites (including any GST) (Promotion Rebate).

- 9. Mirvac make no representation, warranty or guarantee that the Eligible Buyer will receive an incentive (cash or otherwise) from a participating builder in respect of the Eligible Property. Any incentive promoted by a participating builder may be subject to terms and conditions of the participating builder. By participating in this promotion and entering into a Contract, the Eligible Buyer acknowledges and agrees that the Eligible Buyer has not relied upon any statement from Mirvac regarding the availability or amount of any incentive (cash or otherwise) that may be provided by a participating builder.

Further Terms and Conditions of Promotion

The following additional terms and conditions also apply to the Promotion:

- 10. The Eligible Buyer acknowledges and agrees that the Promotion is non-transferrable, nonrefundable and cannot be exchanged for cash. All taxes which may be payable as a consequence of receiving or participating in the Promotion are the sole responsibility of the Eligible Buyer.
- 11. The Eligible Buyer must disclose the contents of this Promotion to any lending institution providing finance to the Buyer to assist with the purchase of the Property.
- 12. The Eligible Buyer forfeits all rights to receiving or participating in the Promotion if the Eligible Buyer does not comply with any of these terms and conditions or any term or condition under the Contract.
- 13. This Promotion cannot be used in conjunction with any other promotion or campaign promoted by Mirvac.
- 14. To the extent permitted by law, Mirvac is not liable to the Eligible Buyer for any direct, indirect, consequential, exemplary, incidental, special or punitive damages arising out of or in connection with the Eligible Buyer's participation in this Promotion even if Mirvac has been advised of the possibility of such damages.
- 15. Prior to an Eligible Buyer's entry into the Contract, Mirvac reserves the right, at its sole discretion, to cancel, terminate, modify, extend or suspend the Promotion at any time without notice.
- 16. If there is any inconsistency between these terms and conditions and the provisions of the contract of sale entered into by a person participating in the Promotion, the contract of sale prevails.
- 17. These terms and conditions are governed by the laws of Western Australia.
